# Release of liability, Waiver of Legal rights and Assumption of Risk

- 1. I acknowledge that kite boarding is an action sport and recreational activity, involving travel in three dimensions and such activity is subject to mishap and even injury while participating in the sport of kiteboarding.
- 2. I hereby release and discharge RIKF and RKA and their officers, directors, elected officials, agents, employees, instructors and owners of equipment and the land used for kiteboarding activities (hereinafter collectively referred to as 'Released parties' from any and all liability, claims, demands, or cause of action that I may hereafter have for injuries, disability, death or damages arising out of my participation in the kiteboarding activities, including, but not limited to, losses CAUSED BY NEGLIGENCE OF THE RELEASED PARTIES.
- 3. I understand and acknowledge that kite boarding activities have inherent dangers that no amount of care, caution, instruction or expertise can totally eliminate. I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN KITE BOARDING ACTIVITIES WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.
- 4. I further agree that I WILL NOT SUE OR MAKE ANY CLAIM against the released parties for the damages or other losses sustained as a result of my participation in the kite boarding activities.
- 5. I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgement, and costs, including attorney's fee, incurred in the connection with any action brought as a result of my participation in kite boarding activities.
- 6. I will take full responsibility for and hold harmless related parties for any injury that I may suffer or inflect upon others or their property as a result of my engaging in the kite boarding activities.
- 7. I agree that I will operate the said kite boarding equipment in a reasonable and safe manner so as not to endanger the lives of persons or property of any individual.

- 8. I have read and understand the above and acknowledge that the same constitutes a release of liability and a waiver of my legal rights and also acknowledge of the assumption by me of all risks arising out of my engaging in kite boarding activities.
- 9. I further represent that this release of liability, waiver of legal rights and assumption of risk shall continue in full force and effect for so long as I engage in kite boarding activities which are in any ways connected to or with the released parties.
- 10.1 further represent that I am at least 18 years of age or that a parent or legal guardian I waive and release any and all legal rights that may accrue to me or to my minor child as a result of any injury that my son or my daughter may suffer while engaging in kite boarding activities.
- 11. I hereby expressly recognise that this release of liability, waiver of legal rights and assumption of risk is a contract pursuant to which I have released any and all claims against the released parties resulting from any participation in kite boarding activities including any claims by the negligence of the released parties.
